

MOTHERS' ROOM AND BREAST PUMP INFORMATION

NXP provides mothers' rooms or other private and secure spaces and reasonable break time to express milk at NXP U.S. sites if you choose to continue breastfeeding after returning to work.

MOTHERS' ROOM LOCATIONS:

Arizona

Chandler – buildings A1 & D2

Texas:

Ed Bluestein – building E2

Oak Hill – buildings D2, F3, H3 & J1

*A room will be made available, but you will need to supply your own breast pump.

Mothers' rooms at the Arizona and Texas locations listed above include Medela® Symphony® breast pumps, curtained stations, a refrigerator, sink, paper towels and storage cabinets.

- ▶ Access to these mothers' rooms can be obtained through your local Occupational Health Resources (OHR) nurses/ Health Centers. Some rooms require key access, others require badge reader access. When you are no longer using the room, please notify Occupational Health Resources so that your badge access can be deactivated and/or any keys you were issued for door access or equipment storage cabinets can be collected.

EACH MOTHER PROVIDES:

- ▶ Supply bottles, bottle brushes, soap, ice packs, insulated containers and any other necessary equipment for pumping, milk storage and transporting milk home.
- ▶ At locations without pumps, mothers need to bring their own pumps.
- ▶ At the Arizona and Texas locations, mothers may choose to bring and use their own personal breast pump or use the NXP-provided Medela Symphony breast pumps available within the mothers' rooms.
- ▶ If you are using the NXP-provided pump, you will need your own personal **Medela Symphony Double Breast Pump Kit**, an attachment kit that is compatible with the pump.
- ▶ Contact OHR to request the attachment kit. Each mother may be given one Symphony Double Breast Pump Kit at no charge.
- ▶ If an additional kit is needed, one can be purchased online (<http://www.medelabreastfeedingus.com/products/91/symphonydouble-breastpump-kit>) or through a local retailer for approximately \$50.
