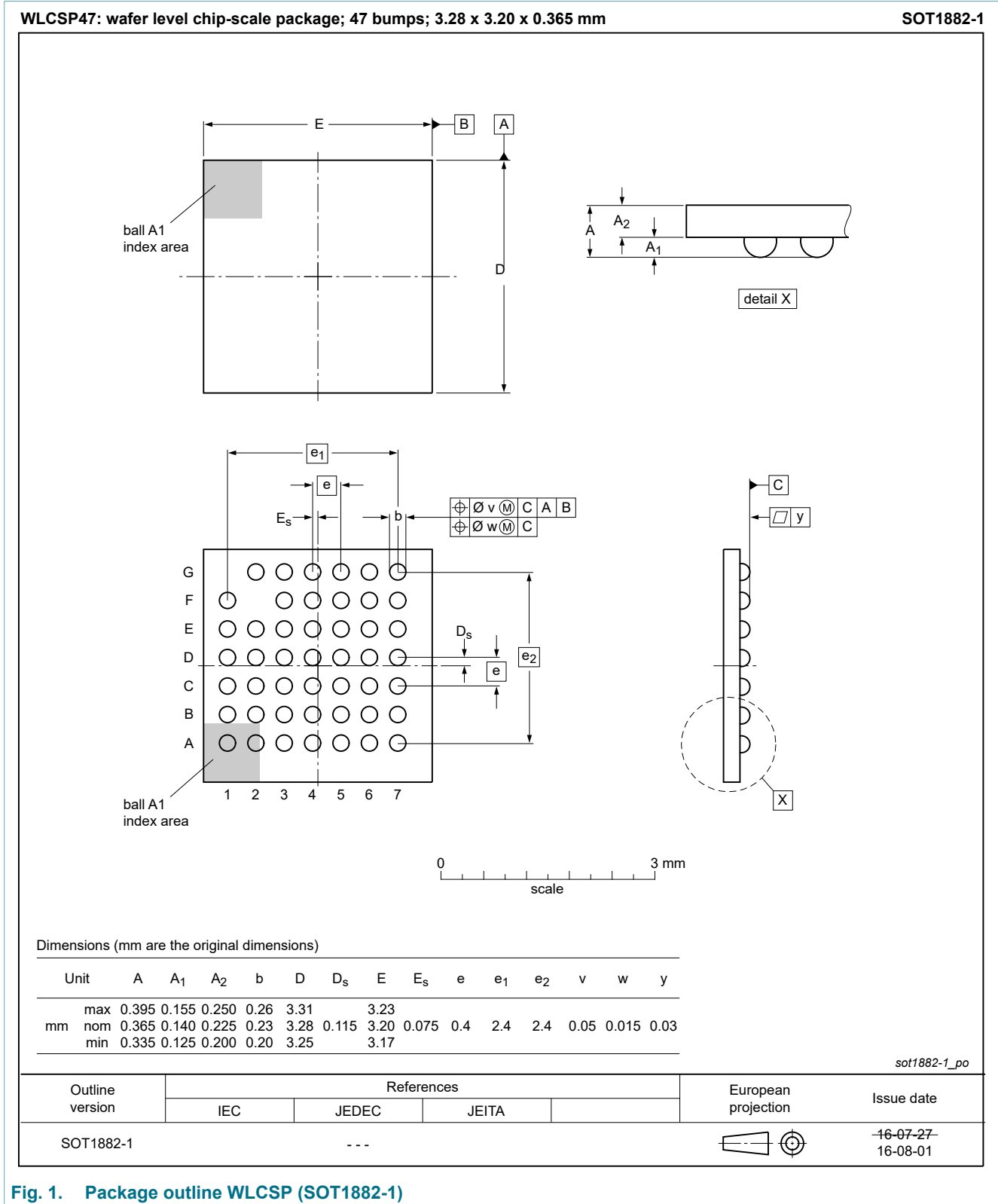

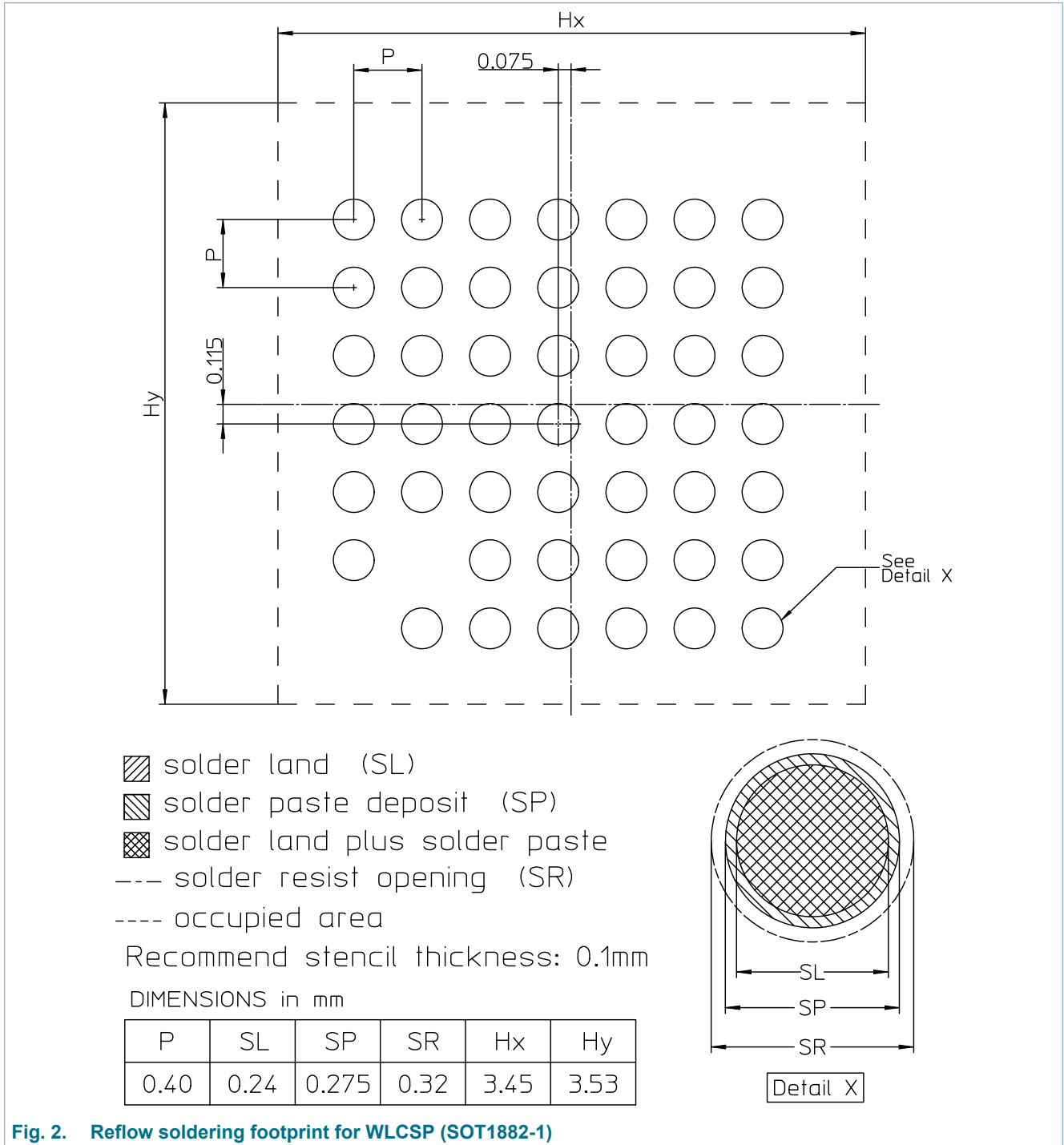


Fig. 2. Reflow soldering footprint for WLCSP (SOT1882-1)
