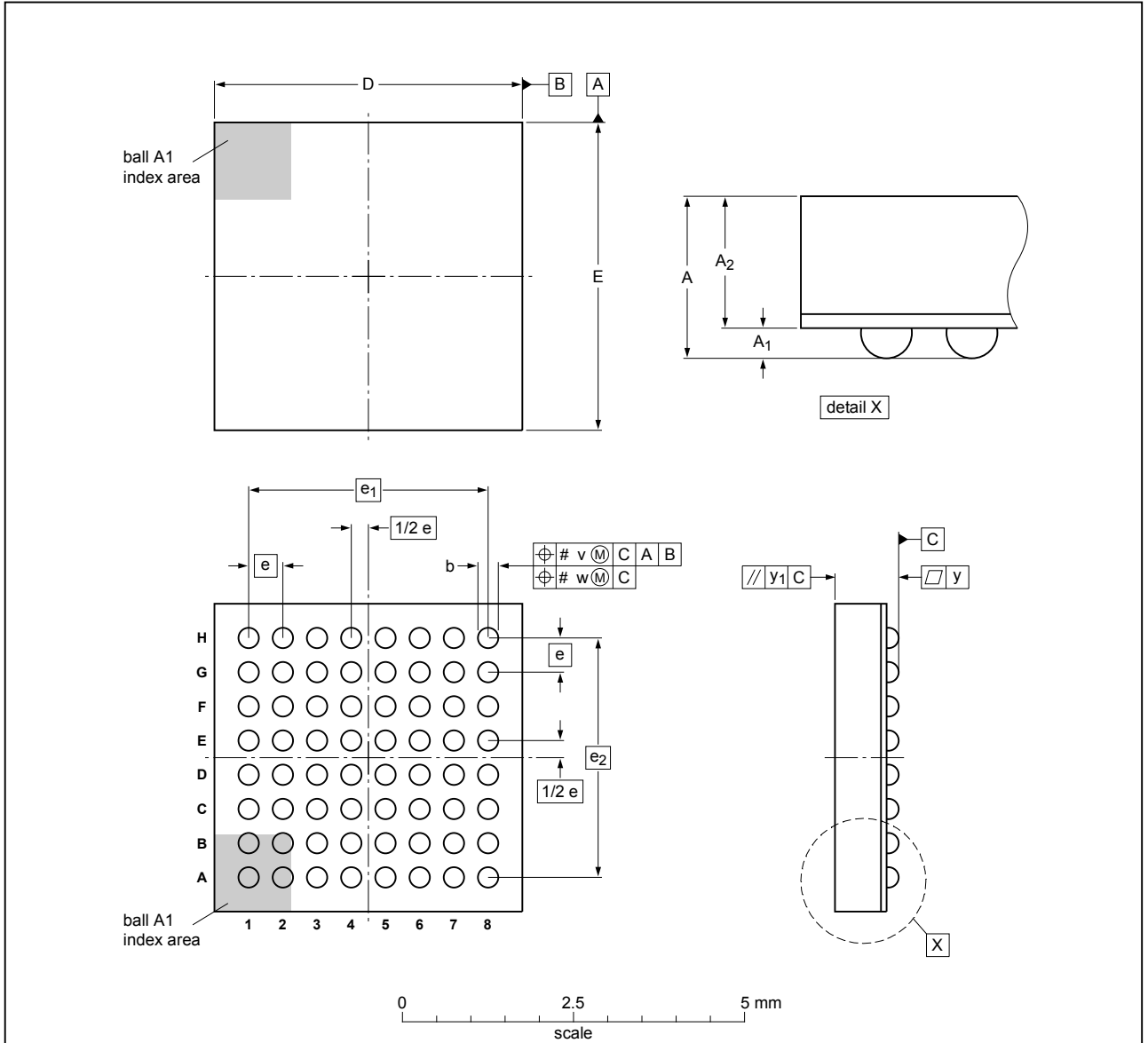

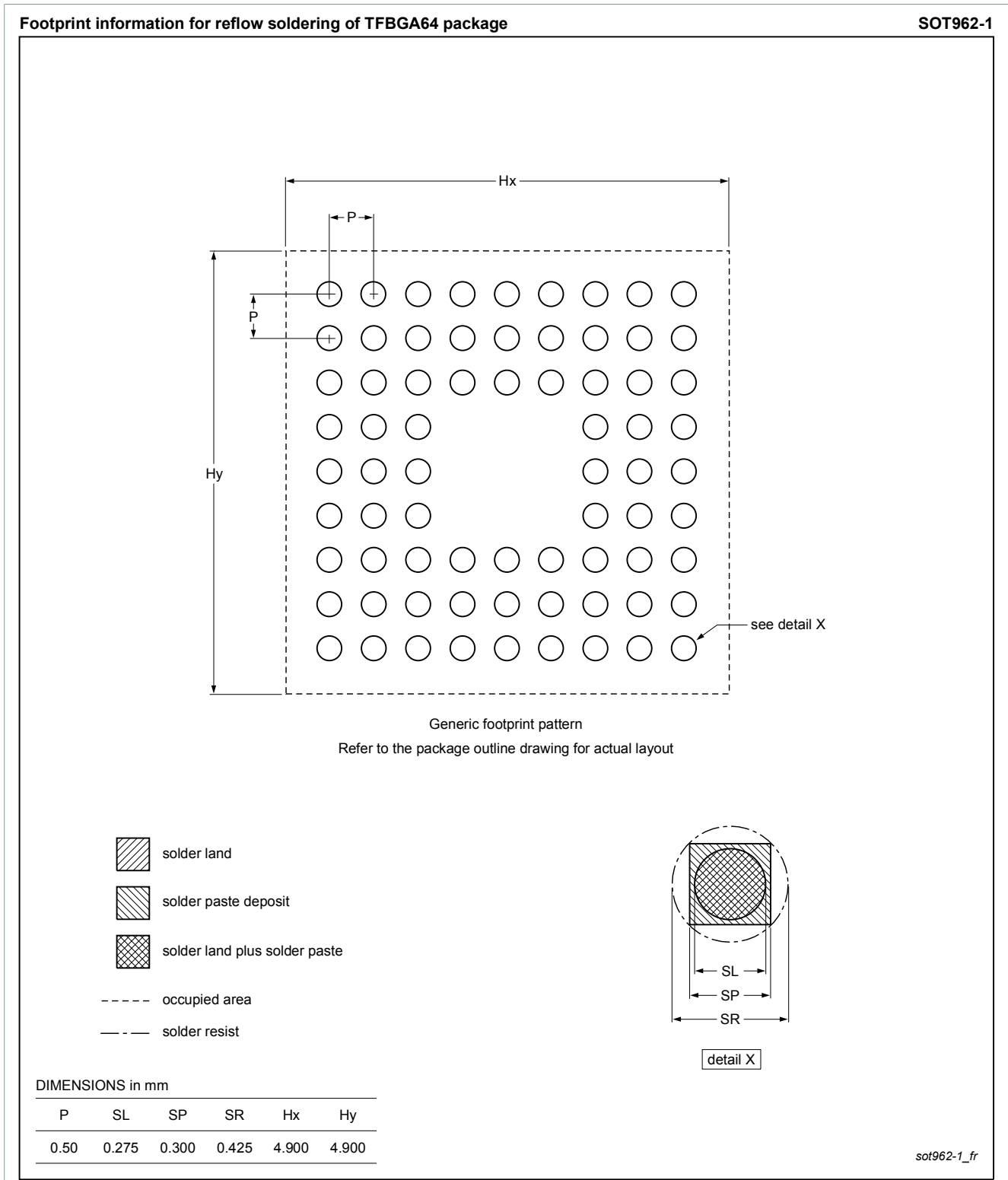


Fig. 2. Reflow soldering footprint for TFBGA64 (SOT962-1)
