

### PFAS Remark :

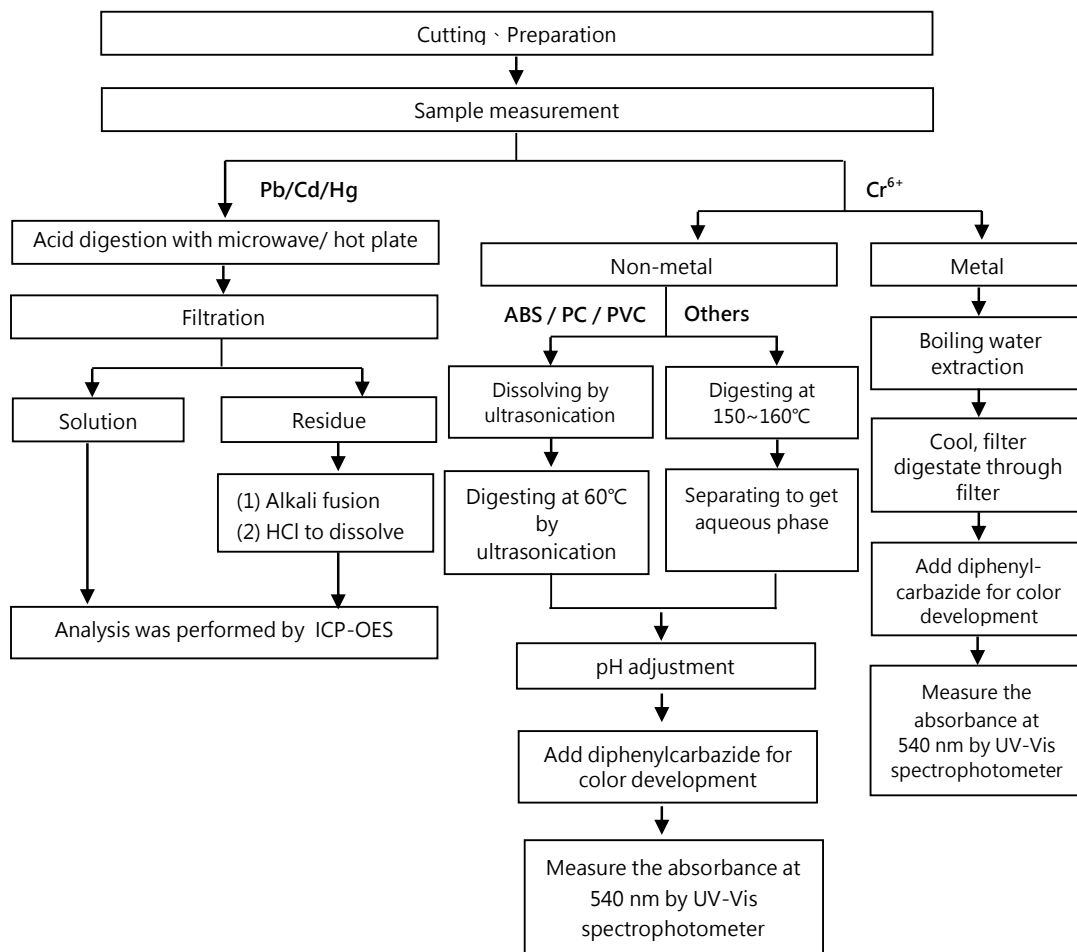

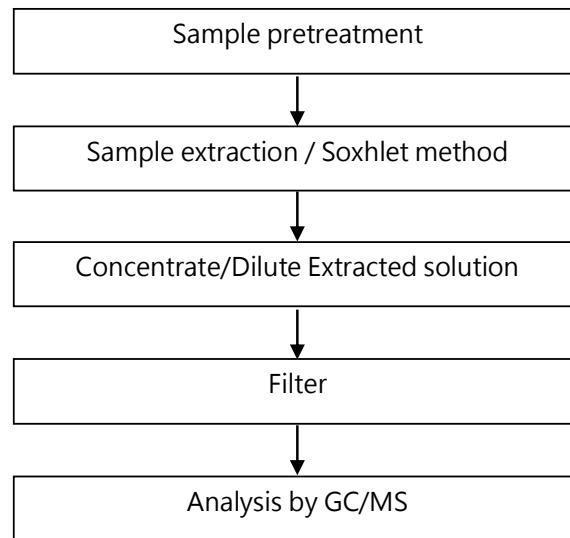

### PBB/PBDE analytical FLOW CHART

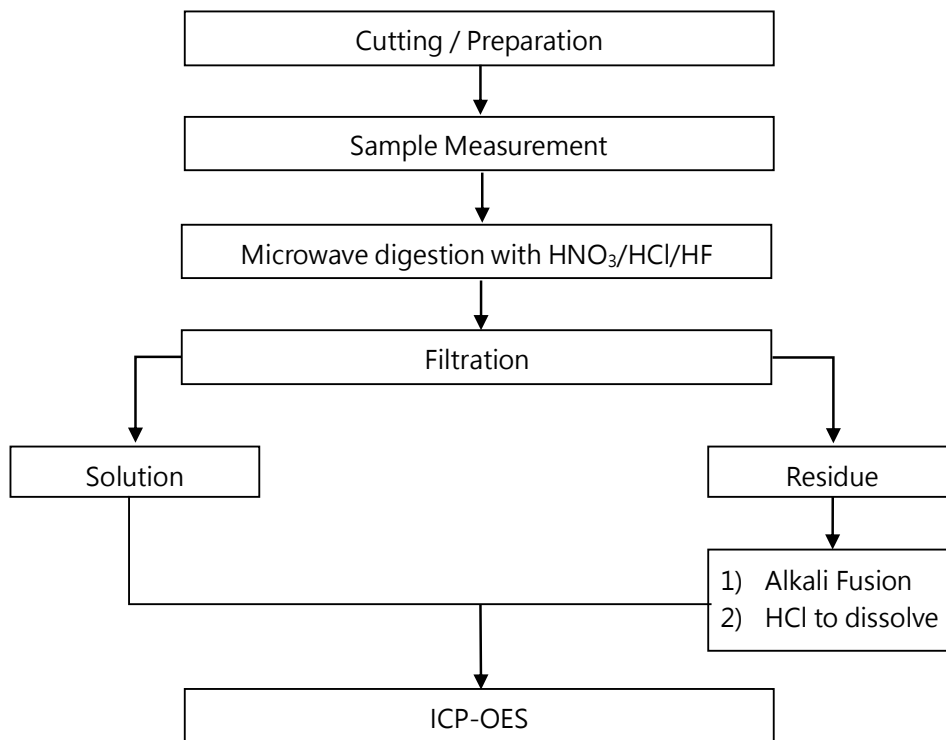

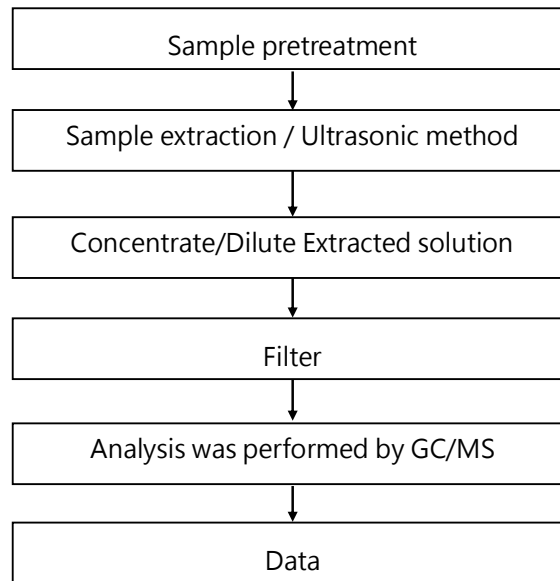

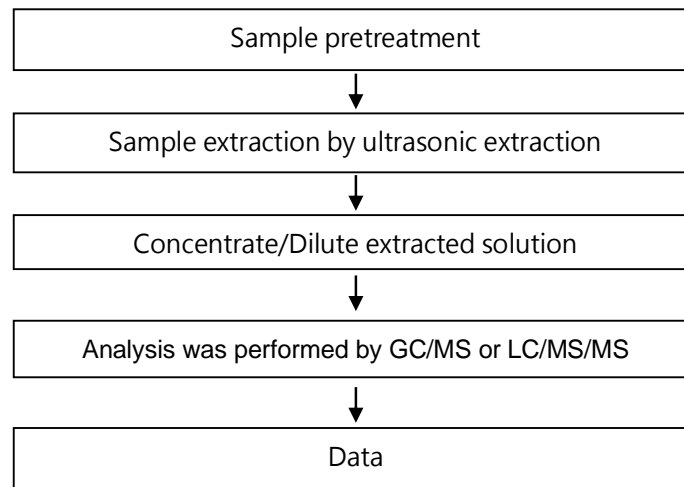
### Analytical flow chart - HBCDD

### Analytical flow chart – PFAS (including PFOA/PFOS/its related compound, etc.)

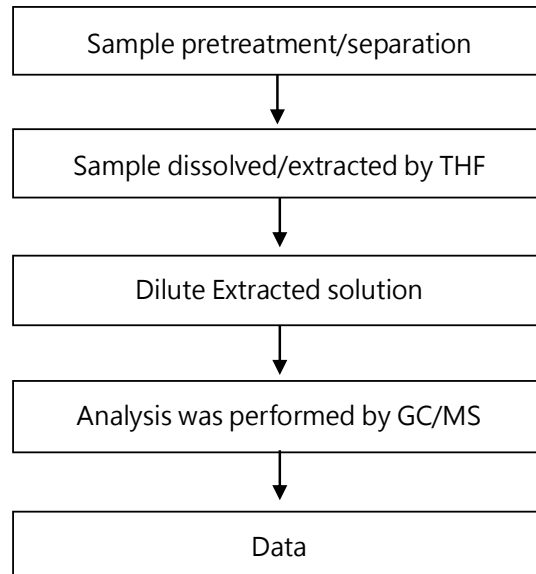

【Test method: IEC 62321-8】

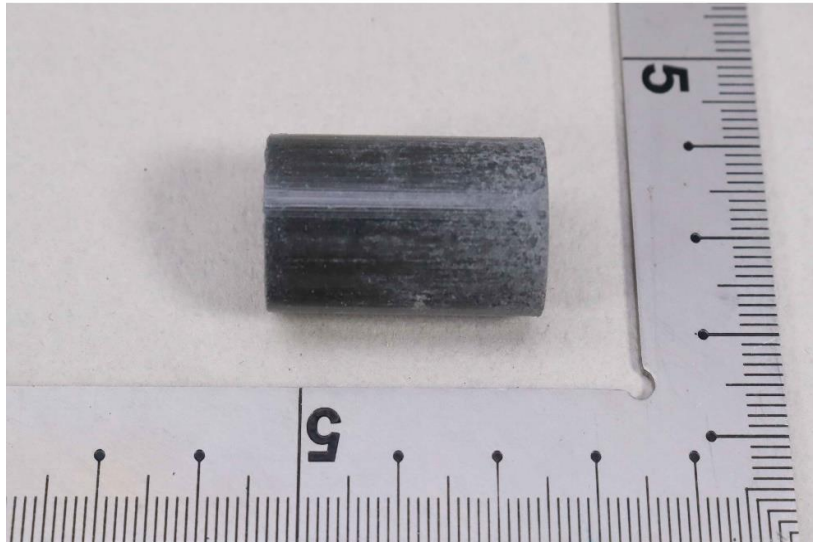
