

PFAS Remark :

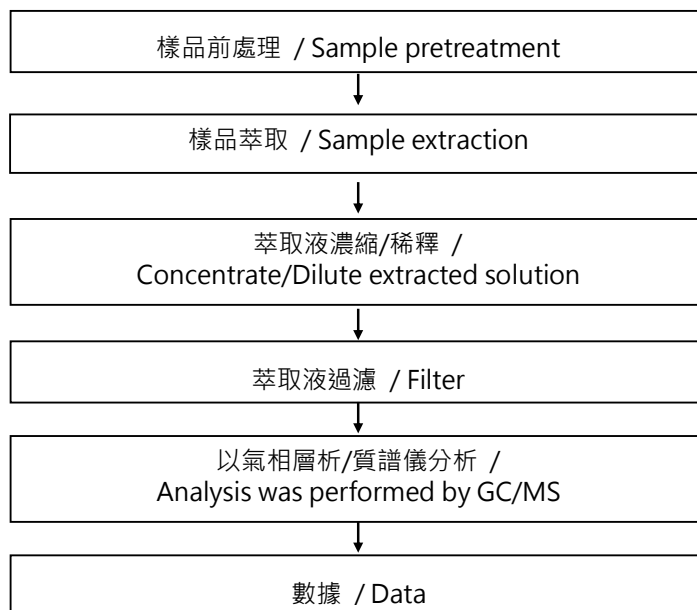

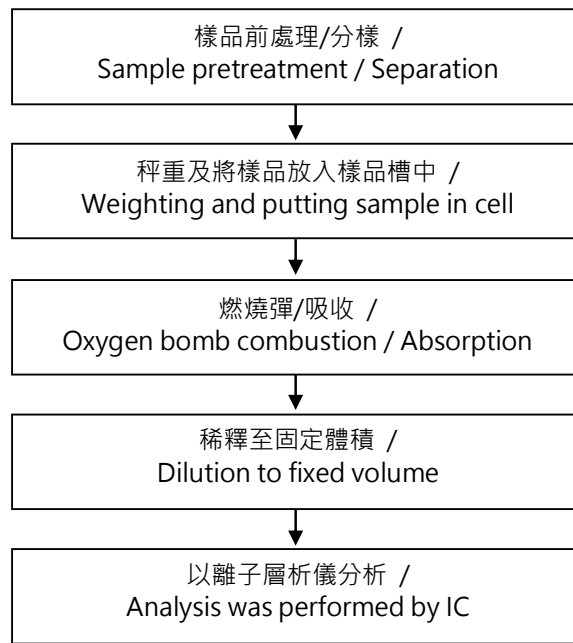

鹵素分析流程圖 / Analytical flow chart - Halogen

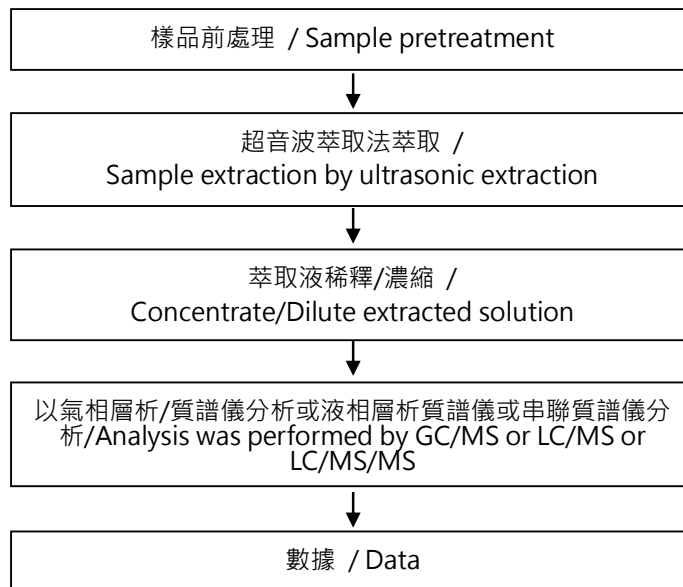

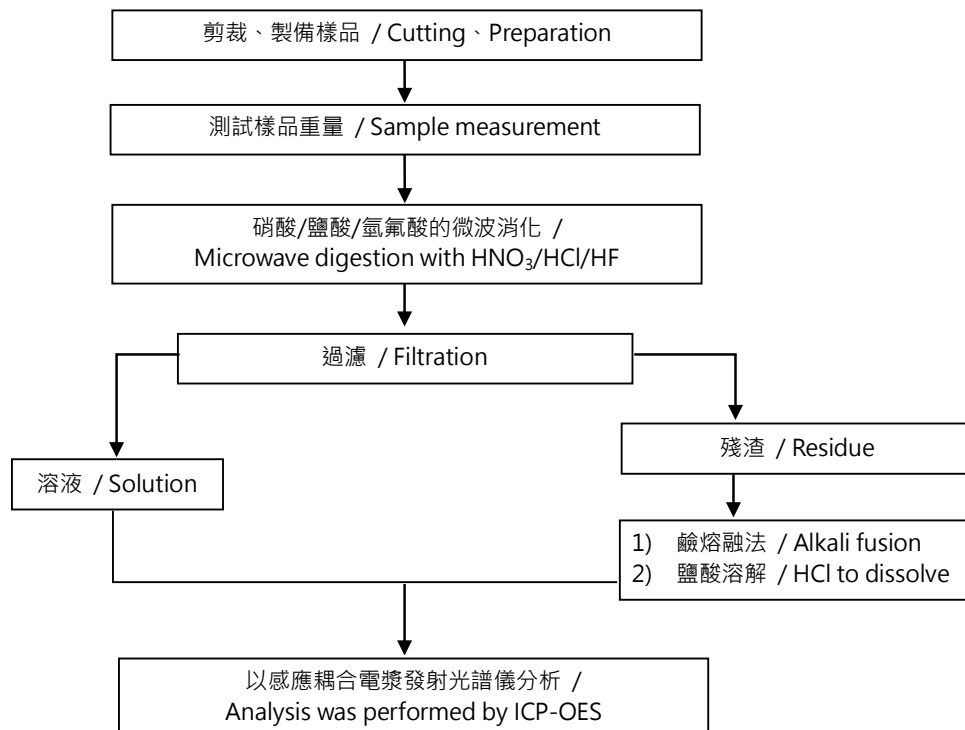

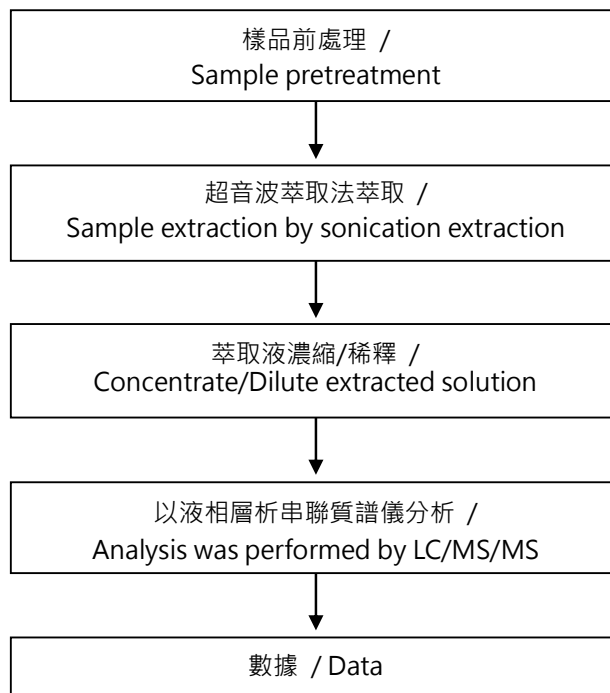
